Duties

Help Ms. Kimber, Maddy, Sarah and Lauren run camp. This means helping children perform crafts, saddling horses, helping children mount, dismount and ride horses, and other duties as assigned to help make camp as fun and engaging as possible for camp attendees.

Qualifications

You must be at least 13 years old. If you are over 13 years old but under 18 years old, your parent must also sign and agree to the terms of this application. You must have at least 1 year of riding experience (more is preferred), know how to saddle, unsaddle and work with horses. You should be good working with children, including children with no riding experience who may be younger, the same age or older than you. You should be outgoing, fun, energetic and have a solid knowledge of the Harry Potter series of books by J.K. Rowling.

Rancho Escondido Summer Camp 2019 will feature a Harry Potter theme and will contain elements, references and crafts from the Harry Potter series of books / movies by J.K. Rowling. Like our camps from previous years, children will spend the week doing crafts, playing games, and, of course, riding horses, but we are adding a Harry Potter theme.

NEW MEXICO EQUINE LIABILITY ACT (42-13-1 NMSA 1978):

There are inherent risks to participants and observers involved in all activities with equine animals due to the propensity of an equine animal to kick, bite, shy, buck, stumble, bolt, rear, trample, be unpredictable or collide with other animals, objects or persons

New Mexico state law provides that no person, corporation or partnership is liable for personal injuries to or for the death of a rider (or other participant) that may occur as a result of the behavior of equine animals while engaged in any equine activities, and that the rider (or other participant) agrees to engage in the equine activity at his own risk
